**Location:** The match will be shot at the Midland County Sportsman's Club, 8825 Sturgeon Road, Midland, Michigan. **Information and Entries mail to:** [Icebula@comcast.net](mailto:Icebula@comcast.net)

**Rules:** Current NRA High Power Rifle Rules will govern. **FEES:** Price \$20.00, juniors pay \$10.00, but are not eligible for awards. There is no penalty for a post entry.

**Time of Firing:** *Squadding will commence at 9:15 AM, at the clubhouse and end at 9:45AM. Firing will commence at 10:00 AM.*

**Classification:** The NRA Mid-Range classification system will be used in all matches.

**Rifle Allowed for record firing:** There will be three divisions: Any Rifle, F-Open, F-TR

**Special Conditions:** Local range rules require that each rifle and sight combination be verified at 100 yards prior to firing the match. Ladder targets will be provided, and verification shots will be taken immediately after the three minute preparation period. Verification shots will not be counted as sighters.

**Weather:** If Weather.com shows a temperature below 30 degrees F, a wind-chill below 25 degrees F, or rain at 10:00 AM the scheduled date the match will be canceled. Watch <http://www.semno.org> for details.

**Course of Fire Friday:**

Match 1 Unlimited sighting shots and 20 shots for record prone in 22 minutes, slow-fire, 600 yards, MR target, Rule 3.7(c), any sights

Match 2 Two sighting shots and 20 shots for record prone in 22 minutes, slow-fire, 600 yards, MR target, Rule 3.7(c), any sights

Match 3 Aggregate of matches: 1, and 2

**Award Disposition:** Awards will be paid for match 3 only. Merchandise or cash awards may be provided by category and classification at the completion of the match.

**Target Service:** Electronic targets will be used.

**Directions to:**

**From the East (from I-75).** Take US-10 to the Eastman Rd. exit. The exit faces Airport Rd. So just cross Eastman and go right onto Airport Rd. Sturgeon is 1 mile to the West. Turn North (right), Club is on left, about 1 1/2 miles.

**From the West (from US-27)** take US-10 to the Eastman Exit. That exits onto Wackerly Rd. Turn right (West) onto Wackerly off the exit. Sturgeon is about 1/2 mile West. Turn North onto Sturgeon and club is about 1 1/2 miles on the left.
